In, producing herewith the arrested accused person namely Mahadeb Sharma (59) s/o Late. Bishunde b Sharma of Shastrinagar, ward no. 41, Tiranga More, PS Bhaktinagar, Dist. Jalpaiguri, arrested U/S 41 Cr.P.C along with following seized articles with proper seizure list:


- i] 12 (Twelve) Bottles of "KINGFISHER STRONG PREMIUM BEER" each bottle containing 650 ml. [Total 7.8 Ltrs]
- ii] 06 (Six) Bottles of "Officers Choice DELUXE WHISKY" each bottle containing 180ml. [Total 1.08 Ltr]
- iii] 20 (Twenty) Bottles of "PET GALAXY BOSS 60 COUNTRY SPIRIT" each bottle containing 300 ml. [Total 6Ltrs]

I, PSI Sailesh Subba of Bhaktinagar PS/SPC do hereby lodge a written complaint against the arrested accused person namely Mahadeb Sharma (59) s/o Late. Bishunde b Sharma of Shastrinagar, ward no. 41, Tiranga More, PS Bhaktinagar, Dist. Darjeeling to the effect that on 12.09.2021 at around 15.10 Hrs received secret source information that one Mahadeb Sharma of Shastrinagar under Bhaktinagar PS has possessed huge amount of illegal liquor at his house for selling the same to local people. Accordingly, I along with C/374 Debraj Biswas, CVF/014 Labanyamoy Barman headed towards Shastrinagar to work out the information. At 15.35 hrs we reached at Shastrinagar Tiranga More, and after being identified by the source I along with force held raid at the house of Mahadeb Sharma and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely Subodh Mohanta s/o Lt Shibu Mohanta and Apu das s/o Lt. Khagendra Ch. Das both of Pradhan Para, Near Mount View Residency, P.O Salugara, PS Bhaktinagar, Dist Jalpaiguri undersigned below of seizure list. The seizure was made between 16.15 hrs to 16.40 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I, therefore request you to register a specific case against the accused person namely Mahadeb Sharma (59) s/o Late. Bishunde b Sharma of Shastrinagar, ward no. 41, Tiranga More, PS Bhaktinagar, Dist. Jalpaiguri, under proper section of law,


