Sir,

I, Smt. Sumitra Prasad Sha, wife of Sri Hari Shankar Sha, Daughter of Sri Prabhu Prasad residing at Jyotinagar, near Don Bosco School, P.S.- Bhakti Nagar, Dist.- Jalpaiguri, State of West Bengal, do hereby lodging this F.I.R., which is as follows:-

(A) That on 22nd Febuary 2004 my marriage was solemnised with one Sri Hari Shankar Sha, Son of Late Gajadhar Sha, resident of Kharibari Bazaar, near Civil Hospital, P.S. Kharibari, District-Darjeeling at my paternal house, mentioned above according to Hindu Rites & Customs.

(B) That at the time of my marriage my in-laws demanded for various gold ornaments and furniture as dowry along with Rs.1,00,000/- in cash and my parents had fulfilled the said demand.

(C) That after my marriage I started my nuptial life with my husband at my matrimonial house i.e. at Kharibari Bazaar, near Civil Hospital, P.S. Kharibari, District-Darjeeling and they kept on demanding for more and more dowry from time to time which my father had full filled time and again but after my father's death my husband started to torture me both mentally and physically due to the lust of more dowry and off & on I had been assaulted by my husband to the optimum level but none of my in- laws had ever try to stop him and that encouraged him further to torture me. It is not out of place to mention here that out of the said wed-lock two children are born named by Aditya Prasad (15 years) and Priyanka Prasad (13 years) but even after their birth the situation had become worse and my husband continued to torture me. It is not out of place to mention here that few months ago he came drunk at home and started to torture me and beat me with an wooden battam on my head and near my eye and with an intention to kill me he brought a sharp weapon and tried to dissect my neck but I raised my right hand immediately to protect my neck and resulting which I received a deep cut injury in my right hand arm. It is added further that I

intimated the said incident before the Kharibari Police Station but at that time the police personnel mediate the matter between us but soon after the mediation my husband inflicted more torture upon me as I had reported the matter before the police personnel.

(D) That on 15-08-2021 the torture reached to its optimum level and he again hit me with a wooden battam at my head resulting which i received injury on my head and hearing my hue and cry my children came to my rescue and with the help of the neighbours they somehow managed to rescue me and informed my brother and they brought me and my children at my above mentioned parental house and for my head injury I had to consult a doctor and my treatment is still going on under neurologist, it is pertinent to mention here that despite an Indian lady I tried my best to live with my husband but all in vain and instead he is giving me life threatening calls and also threatening me that he will take both of my children away from me and would kill me if he ever see me in person.

Being helpless, I am praying before you to take appropriate legal action against the said miscreant so that I can get proper justice from the administration.
