Dear Sir,

I, Kalachand Kundu aged about 64 years, son of Late Sailwshwar Kundu, residing at Bidhan Road, Siliguri beg to report you that We have a tea plantation in an area around 30 acres of land, situated at Chobavita, Fulbari.

That today at around 11.30 A.M. a gang of 50 to 60 miscreants led by Hasibul of KPP, Nagendranath Roy and Saroj Roy. came in 4 to 5 goods carrier pickup vans in front of my camp office opposite to our factory Gobra Agro products Pvt, Ltd. They were carrying, Lathi, batons and also flags of KPP. They took my security guards at hostage and snatched their mobile phones and damaged CCTV cameras, fans, monitors and other articles installed there, and took away cash, and DVR box with them to destroy all evidences. Before leaving they threatened our security guards with dire consequences.

I am a senior citizen and after this incident I feel unsafe and also worried about the safety of my people and my property.

I therefore request your good self kindly look into this matter and take proper action as per Law.
