West Bengal, would like to bring to your kind  
attention to the following facts for your kind  
consideration and necessary action that:

I am being threatened of defamation in social  
media like Facebook, Instagram and Whatsapp  
by my ex-boyfriend, Sanjoy Sharma, S/O  
~~Sh~~ Sahadeb Sharma, a resident of Shivmandir,  
Fasidua More, Siliguri.

Sanjoy Sharma has been blackmailing me since  
few months by coming to my house at late  
night and creating disturbances by blowing loud  
car horns. He had also intruded my house  
in my absence and showed nude pictures of  
random girls to my mother to do the



Same with me, in the month of January and February, 2021 which had left her in utter shock and trauma.

After which my mother, Smt. Munna Basnet had confronted him few months back at his home in the presence of his mother and sister to stop harassing me or stern legal action will be taken against him, He had happened to stop for few months.

But since 8<sup>th</sup> of September, 2021, he has again started threatening me making lewd comments that if I don't get back into relationship with him again, he is bound to do anything against me and put me to blame on 9<sup>th</sup> of September, 2021 I came to know that he had been creating fake accounts in my name as Aishu Kumari and Aisha Kumari on social medias like Facebook and in Instagram name as aishwariya Kumari Basnet and whatsapp and sending inappropriate message to my family members and friends and then trying to defame me again.

Besides that Sanjoy Sharma used to follow, abuse and stalk me. Once he molested me
