With due respect I Sri Dipankar Mandal @ Dipu, S/o Sri Dulal Mandal of Gostho Paul Sarani, Ward No.15 of S.M.C, Hakimpara, P.O & P.S-Siliguri, District-Darjeeling would like to inform you that I am a driver by profession, and on 11.09.2021 at about 10 P.M a Ford Ecosport crossed me and suddenly applied the break in his vehicle as a result of which my bike hit his car at Punjabi Para, I and my pillion rider fell down from the bike.

After we fell from the bike I told sorry but the abovenamed miscreant namely Souvik Kundu @ Tipu, Son of Late Subhash Kundu started beating me and took away my gold chain weighting 20.73 grams, Suman Dutta and 3 other persons in the car came out and started to beat me and Dipankar Saha and took both of our wallet containing a cash of Rs 20,000/- (Rupees Twenty Thousand) only in total. I came to know the principal miscreants name from facebook his name is Souvik Kundu, Son of Late Subhash Kundu, Residing near Ulka football field, Jyotinagar, Ward No.41 of S.M.C, P.S-Bhaktinagar, District-Jalpaiguri, Pin-734001 and his phone number is 9083103667. I am a poor guy and run from pillar to

poles to earn my livelihood and I have saved hard to buy a gold chain and a gold ring, moreover he took my and my friends wallet containing cash of Rs 20,000/- (Rupees Twenty Thousand) only.

I therefore request your good office to look into the matter and take necessary action against the miscreants and recover the stolen articles from their illegal possession.

I along with my pillion rider was treated at Siliguri District Hospital.

Please treat this as most urgent and do the needful.
