Daijeeling would like to inform you that today i.e. on 14/9/21 at about 6.00 P.M. my neehiban namely Mino Paswan came in front of my house and without any reason she started to quarrel with my daughter namely Neha Kumari Mahato and my relative (Bhavi) Rekha Devi Mahato and after listening the same when my daughter and Bhavi tried to protest the same at that time she called his relatives namely ① Mino Paswan, ② Bishna Paswan, ③ Raju Paswan, ④ Sanju Paswan, ⑤ Anjan Paswan, ⑥ Karki Paswan, ⑦ Kamchan Paswan, ⑧ Manchan Paswan, ⑨ Dhiraj Paswan and ⑩ Ninaj Paswan and ^{after} ~~where~~ the above noted persons came to the spot they also used bad languages in respect of my family member and when they tried to protest the same at that time they all of them became furious and started to assault them with the help of some deadly weapons such as lathi and kheebor that reason they sustained multiple injuries on their heads and body and after listening me and my I along with my relatives came to the P.T.O.

spot and tried rescued them at that time
they also assaulted me with fist and blow
and I also sustained injury but some how
with money and I and my relatives took them
at Siliguri Sadar Hospital and right now
they admitted there and fighting with life and
at the time of the said incident they also
disrobe them with the intention to outraged
their modesty and right now I spend
my days with in fear so, I lodged this
complaint before you

Therefore I request you be pleased
to take necessary legal action against
them as early as possible.
