Phansidewa Dist Darjeeling would like to inform you that today on 06.00 AM when I was at my house I heard some noise coming from outside I came out to verify the noise and saw that one big bus with R/C No - UPS3 BT 5256 loaded with goods was overturned near Church More, Karkali High Way. I also came to see that the driver of the vehicle was trapped inside the overturned vehicle and also a dead body of one of the vehicle associated had already been shifted to Narjeeban Hospital.

After best of efforts by the local PS vans and other local people the driver was pulled out of the overturned vehicle and later rushed to Narjeeban Hospital along with the dead body.

Therefore I would like to request you to take necessary legal action request in the incident.
