Subject : First Information Report

Sir,

I, Tapashi Mallick, daughter of Late Badal Mallick resident of Phansidewamore, Shivmandir, P.S Matigara District Darjeeling, would like to inform you that one Mukul Kanti Ghosh son of Late Anil Kumar Ghosh resident of Ramkrishna Sarani, Shivmandir, P.S Matigara had approached me, my sister and my brother on March 2021 threatening us that we immediately have to give in his son name registration of two shops situated at phansidewa more near SJS school on the Asian Highway 2 which belong to us. As my younger brother Late Kaushik Mallick had entered into the agreement with him. That I strongly protested by saying that we have not received any money and if he can show the payments made by him then we can do the needful. He said my late brother had agreed to sell the shops for an amount of Rs 1500000/- . Whereas one shop in our area is worth more than 34 lakhs. That we said we will first verify the details and talk to him. That today on 20/08/21 at 11:30 am. O clock the said Mukul Kanti Ghosh, Kamakha Ghosh son of unknown resident of Bagdogra along with several other hoodlums came to our said building and started breaking the lock of two shops for taking forceful possession. That I immediately rushed to the spot and objected by saying how dare you and your associates break my property. To this the said Mukul Kanti Ghosh used abusive language calling me a prostitute and holded my hand and when I resisted he pulled my saree and disrobed me and pulled my hair by saying that today any how they will take the possession of the two shops and even the police are with them and I started crying for help, he pressed my throat as a result I started chocking. In the meanwhile my younger sister also came along with some men and they rescued me from his clutches, the other men along with said Mukul Kanti Ghosh threatened us that we have to give registration of the said two shops and he will not pay a single penny for the same to us and if we didnt he will not allow us to live in shivmandir. That when I again protested I was beaten up by a person namely, Bappa Chackroborty son of unknown resident of shivmandir and as a result I fainted. That I was immediately taken to hospital. That when I was taken to hospital my younger sister Tanushree Mondol(Mallick) resisted them the said Mukul and Bappa also assaulted my younger sister and started breaking the lock and after opening the shop they stole all the wooden block kept in our shop worth Rs 50,000/- .That from there I went to Matigara police station but police didnot take the FIR. So I request you to take immediate action against Mukul Kanti Ghosh and his associates.
