Respected Sir,

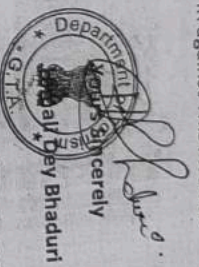
I am Smt. Himali Dey Bhaduri In-Charge of Pahariya Bhawan, Himachal Vihar Gorkhaland Territorial Administration Tourism Department. I would like to inform you that one inhabitant of Himachal Vihar Sri PK Dutta constructed a four storied building at plot No. B-15, Phase-1, Himachal Vihar, Matigara, Dist- Darjeeling (WB) and he has operating Lodge/Hotel in the said building in the name & style of "USHASHREE" Lodge in unauthorized manner without any legal authority. He is continuously operating lodge in current COVID-19 pandemic situation and violating order dated 15.05.21 for lock down issued by the Chief Secretary, Government of West Bengal (Ref: No. 647-ISS/ZM-22/2020).

As our G. T. A authority has put up a Board of Pahariya Bhawan at the enter of Himachal Vihar gate one of my security name Madhav Dhar doing duty at night, so while coming for duty he had notice the Board was taken off and was toned and lying on the road. Later, we came to know that it was done by Sri PK Dutta. I said him to talk to Sri PK Dutta and hes abused my security guard over the telephone and threatened him by saying that he will throw off all the board displayed on the road.

After That myself, I have spoken to Sri PK Dutta (8250661108) while speaking to him he had also misbehaved me over the telephone .

So I therefore In view of above facts, I request you to take appropriate legal steps against Sri PK Dutta and also take necessary steps for closing such illegal activities from the said premises.
