Sir,

In producing herewith one arrested accused person namely Ramnarayan Yadav(38) S/O-Lt. Ramphul Yadav of Chirag Gas Godown, Sukanta Pally P.O- Pradhannagar, P.S- Matigara, Dist-Darjeeling along with one seized vehicle bearing no- WB- 71/A-0722(Shaktiman) loaded with river bed materials under proper seizure.

I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Ramnarayan Yadav(38) S/O-Lt. Ramphul Yadav of Chirag Gas Godown, Sukanta Pally P.O- Pradhannagar, P.S- Matigara, Dist-Darjeeling, the driver of Seized vehicle bearing no- WB- 71/A-0722(Shaktiman) loaded with river bed materials to the effect that today on 16.09.2021 at 09.32hrs received a specific source information that one vehicle bearing no- WB- 71/A-0722(Shaktiman) loaded with river bed materials had been moving along the high way towards City Centre. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS myself along with assisting force left PS to verify the veracity of source information. On the way towards City Centre I detained a vehicle bearing no- WB- 71/A-0722(Shaktiman), loaded with river bed materials, at Chamta River Bridge and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Ramnarayan Yadav(38) S/O-Lt. Ramphul Yadav of Chirag Gas Godown, Sukanta Pally P.O- Pradhannagar, P.S- Matigara, Dist-Darjeeling. On demanded he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no- WB- 71/A-0722(Shaktiman) stated that he is involved in carrying of river bed materials by illegal means for his wrongful gain since last few months without consent of his owner namely Rajesh Minj . Accordingly I seized the vehicle bearing no- WB- 71/A-0722(Shaktiman) being loaded with river bed materials and subsequently arrested the driver named Ramnarayan Yadav(38) S/O-Lt. Ramphul Yadav of Chirag Gas Godown, Sukanta Pally P.O- Pradhannagar, P.S- Matigara, Dist-Darjeeling. The whole process of seizure and arrest was made in between 10.15 hrs to 10.35 hrs.

Hence, I pray that a specific case may kindly be started against the driver namely Ramnarayan Yadav(38) S/O-Lt. Ramphul Yadav of Chirag Gas Godown, Sukanta Pally P.O- Pradhannagar, P.S- Matigara, Dist-Darjeeling of above noted vehicle bearing no- WB- 71/A-0722(Shaktiman) loaded with river bed materials under proper section of Law and arrange for its investigation.
