After disclosing our identity, I asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served them option notice u/s 50 of NDPS Act accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any one in writing in the notice serve to by them. document in support of possessing of the Ganja which was kept inside on their bags.

I accordingly weighted the seems to be Ganja by the weighing instrument and found total 6.220 kgs marked as exhibit- "A" and 7.570 kgs marked as exhibit- "B" kept inside the two luggage bag mentioned above which the both bag caught by Priyoranjan Mirdha and found total 7.470 kgs marked as exhibit-"C" kept inside the bag which was caught by the Polash Mohanto and 100 Grams of seems to be Ganja taken as sample from the each three packet from the Exhibit -A, B and C in three separate plastic packet and marked as A-1, B-1 and C-1, I labeled and sealed all the article in presence of Sri Narendra Kalicotay, ACP, (SB), SPC and Independent witnesses and accused persons. Then, I seized the above noted articles on weighing total 21.260 kgs of Ganja under proper seizure list and lebel duly signed by the above noted witnesses and the Special Executive Magistrate Sri Narendra Kalicotay, ACP, (SB), SPC and acknowledged by the accused persons. The seizure was made in between 18.00 hrs to 19-05 hrs. On further asked the apprehend persons confessed in presence of Special Executive Magistrate Sri Narendra Halicotay, ACP, (SB), SPC and the witnesses that they procured the seems to be Ganja clandestinely for the purpose of selling in order to earn huge money quickly. On interrogation they disclosed that they had been dealing in such business for last few years importing from Coochbeher, Assam and selling the same to Bihar. Then, I arrested the above noted accused persons u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act possessing huge quantity of seems to be Ganja without any valid documents or license.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the both accused persons namely i) Priyoranjan Mirdha 29yrs s/o Chittaranjan Mirdha of Vill, Champasari Middle Palash near Hanuman Baje House PO: Champasari PS, Pradhannagar Dist, Darjeeling II) Palash Mohanto 28yrs s/o Late Biswwa Nath Mahanto of Debidanga bazaar near Uday Sangha Sporting Club PS, Pradhannagar Dist, Darjeeling and arrange for its investigation.
