Sir,

With due respect, I am producing herewith the arrested accused person namely Prakash Thakur (50 yrs) S/O Late Maheswar Thakur of South Colony Bazar, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.
2. 06 (Six) bottles of 60 up Captain Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 16.09.21 at 18.45 hrs I received a secret source information that one person namely Prakash Thakur of South Colony Bazar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at South Colony Bazar, PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 688 dated 16.09.21 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Kr Mahato and CV/306 Biswajit Roy all of NJP PS, SPC left for South Colony Bazar to work out the information in hand. At about 19.15 hrs we arrived at the shop of Prakash Thakur of South Colony Bazar, PS- NJP, Dist.- Jalpaiguri. I held raid and managed to apprehended one person. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 19.35 hrs to 20.25 hrs on 16.09.21.


Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Prakash Thakur (50 yrs) S/O Late Maheswar Thakur of South Colony Bazar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
