Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 688 dated 16.09.21 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Kr Mahato and CV/306 Biswajit Roy all of NJP PS, SPC left for South Colony Bazar to work out the information in hand. At about 19.15 hrs we arrived at the shop of Prakash Thakur of South Colony Bazar, PS- NJP, Dist.- Jalpaiguri. I held raid and and managed to apprehended one person. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On scarch the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop.
