I, ASI Khagen Barman of NJP PS, Siliguri Police Commissionerate beg to state that on 15.09.21 at 00.15 hrs I received a secret source information that a gang of miscreants come to Dokanghora More, Jatiakali under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Jatiakali area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 595 dated 15.09.21. As per kind order and direction of my superior officer myself along with ASI Sajal Das., VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Dokanghora More to work out the information in hand. I also informed the fact to night RT Van officer SI Ganesh Roy and requested him to come to Dokanghora More to accompany with us. At about 00.35 hrs on 15.09.21 we arrived at near Dokanghora More, Jatiakali under PS- NJP, Dist.- Jalpaiguri. After a few time SI Ganesh Roy along with force came there and accompany with us. At about 01.05 hrs we found that 11/12 persons assembled in a dark place at beside Dokan Chora More, Jatiakali and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 05 (five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and give different statement in different time and finally they disclosed that they assembled there to commit dacoity at Jatiakali area.
