I, Shabnam Khatun (25) w/o Md. Raurak,  
resident of C/o Md. Sagir, South Ambedkar Colony

P.S. Pradhan Nagar, Distt- Darjeeling, beg to  
inform you that, my marriage was solemnized  
with Md. Raurak s/o Md. Roshan, of South  
Ambedkar Colony (Near Durga Mandir), Ward No. 1 SMC  
C/o Sambhu Bogel, P.O. & P.S. Pradhan Nagar, Distt-  
Darjeeling under Islamic law & Customs, nearly  
05 (five) years ago, but since after my marriage, my  
said husband started subjecting me for physical  
and mental cruelty.

On St. 13.09.2021 at about 09-30 am, when  
I was at my matrimonial house at C/o Md. Sagir,  
South Ambedkar Colony, (Near Hanuman Mandir)  
Ward no. 1 SMC, P.O. & P.S. Pradhan Nagar, Distt-  
Darjeeling, at that time, my said husband started  
abusing me in filthy languages in intoxicated  
condition, and when I protested, he started beating  
me with fist & blows, then I called my brother  
namely, Md. Rahmat s/o Lt. Md. Aabid, of Adarsha  
Nagar Math, Ward No. 4 SMC, P.O. Siliguri Bazar, P.S.-  
Siliguri, Distt- Darjeeling, and he interfere into  
the matter, then my said husband also abused my  
brother in filthy languages and threatened us  
for dire consequences.

Then I left my matrimonial house and came  
back to my brother namely, Md. Rahmat house's  
at Adarsha Nagar Math, noted above, with my  
02 (two) children and presently residing there.

Sir, my said husband is a habitual drinker  
and not maintaining me and my children, and  
for the safety of my life & limb, I am presently  
residing with my brother namely, Md. Rahmat at  
Adarsha Nagar Math, Ward No. 4 SMC, P.O. P.S. Siliguri

So, please take necessary action against my  
said husband namely, Md. Raurak, presently residing  
at C/o Md. Sagir, South Ambedkar Colony (Near  
Hanuman Mandir) Ward No. 1 SMC, P.O. P.S. Pradhan  
Nagar, Distt- Darjeeling.
