In producing herewith the arrested accused person namely Sufal Rai s/o Lt Pradip Kumar Rai of Raj Fapri, Near BSF Camp, P.O Salugara, PS Bhaktinagar, Dist. Jalpaiguri arrested U/S 41 Cr.P.C. along with following seized articles:

- 1) Ten (10) Bottles of 'KINGFISHER STRONG PREMIUM BEER' each bottle containing 650 ml. [Total=6.5 Ltrs.]
- 2) Ten (10) Bottles of 'TUBORG PREMIUM BEER STRONG' each bottle containing 650 ml. [Total=6.5 Ltrs.]

I, PSI Suresh Subba of Bhaktinagar PS/SPC do hereby lodge a written complaint against the arrested accused person namely Sufal Rai s/o Lt Pradip Kumar Rai of Raj Fapri, Near BSF Camp, P.O Salugara, PS Bhaktinagar, Dist. Jalpaiguri to the effect that on 16.09.2021 at around 14.35 Hrs received secret source information that one Sufal Rai has possessed huge amount of illegal liquor at his Shop at Raj Fapri, under Bhaktinagar PS for selling the same to local people. Accordingly, I along with C-702 Mejbul Rahman, CVF/014 Sumit Roy and CVF/014 Labanyamoy Barman headed towards Raj Fapri to work out the information. At 16.25 hrs we reached at the spot, and after being identified by the source I along with force held raid at the Restaurant at Sufal Rai styled as "Nishu Fast Food" and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses undersigned of seizure list. The seizure was made between 16.55 hrs to 17.15 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to register a specific case against the accused person namely Sufal Rai s/o Lt Pradip Kumar Rai of Raj Fapri, Near BSF Camp, P.O Salugara, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
