In producing herewith one arrested accused person namely Jamil Akter (36) s/o Gul Mohammad of Huskunda, Panjipara, PS Goalpukhur, Dist Uttardinajpur (not verified) along with the following seized articles under seizure as per seizure list:

[i] 01 (One) transparent plastic packet containing 250 grams said to be Brown Sugar kept in a white coloured plastic packet which was kept inside in his pants pocket marked as Exhibit-"A"

[ii] One transparent pouch containing 10 grams of said to be Brown Sugar taken out as sample from Exhibit "A" for examination and marked as Exhibit "A-1"

I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 16.09.2021 at about 18.05 hrs, I received a specific source input from SOG (Special Operation Group) team Siliguri Police Commissionerate that one male person is standing at Chandal More, under Bhaktinagar with huge quantity of brown Sugar for delivering the same to his designed customers at Siliguri. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 759 dated 16.09.2021 and subsequently, I informed the matter to the I/C Bhaktinagar PS, SPC and being directed, myself along with force with investigation kit left for Chandal More, Prakashnagar under PS- Bhaktinagar by govt. vehicle to verify the veracity of the information vide Bhaktinagar PS GDE no. 760 dated 16.09.2021 and M.C.C No- 763/2021 Dated 16.09.2021. We were assisted by SI Rasbihari Saha and ASI Binod Jha of SOG, SPC.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Chandal More and at about 18.25 hrs. on being pointed by source detained the above noted male person who was standing at Chandal More and waiting for someone. Thereafter, we detained him and disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he disclosing his name and address as noted above and admitted that he has illegally possessed brown sugar in their possession for selling the same to his designed customers as per requirement.

I then gave them option whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched in presence of any one of the above. Accordingly, I informed the matter to Sri Amaresh Singh I/C Bhaktinagar PS, SPC, as a Gazetted officer, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Chandal More to remain present and to supervise the search and seizure.

Accordingly at 18.50 hrs Sri Amaresh Singh I/C Bhaktinagar PS, SPC, arrived at the spot as a Gazetted officer and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities keeping his decency and recovered the above noted articles from the exclusive possession of above noted accused person. Subsequently, being demanded in presence of Sri Amaresh Singh I/C Bhaktinagar PS, SPC as a Gazetted officer the detained persons failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 250 grams said to be Brown Sugar exclusive of above noted accused person and marked as "Exhibit- A" and I also taken 10 grams of said to be Brown Sugar respectively from Exhibit-A and Marked as Exhibit-A1 as sample for examination. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the witnesses namely (1) Suraj Chhetri s/o Man Bahadur Chhetri of Ramchandra Nagar, ward no-42 PS Bhaktinagar Dist Jalpaiguri and (2) Prabhat Prasad s/o Ram Prasad of Vivekanandanagar, ward No-42 PS Bhaktinagar Dist Jalpaiguri. Sri Amaresh Singh I/C Bhaktinagar PS, SPC, arrived at the spot as a Gazetted officer and acknowledged by the accused person. I also labeled and sealed all the articles in presence of Sri Amaresh Singh I/C Bhaktinagar PS, SPC, arrived at the spot as a Gazetted officer and witnesses and accused persons. The whole process of seizure was made in between 19.20 hrs to 20.10 hrs.

Being further asked, the apprehend person namely Jamil Aktar (36) s/o Gul Mohammad of Huskunda, Panjipara, PS Goalpukhur, Dist Uttardinajpur admitted in presence of Sri Amaresh Singh I/C Bhaktinagar PS, SPC as a Gazetted officer and other witnesses that he procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that he have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused person namely Jamil Aktar (36) s/o Gul Mohammad of Huskunda, Panjipara, PS Goalpukhur, Dist Uttardinajpur (not verified) after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons Jamil Aktar (36) s/o Gul Mohammad of Huskunda, Panjipara, PS Goalpukhur, Dist Uttardinajpur (not verified) is
