Sir,

in producing herewith one accused person namely Swapan Das (43), S/O- Late Rakhal Das of Purba Majahari PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 17 (Seventeen) bottles of "HIMALAYAN GOLD PREMIUM 60 SP COUNTRY SPIRIT" each bottle containing 600 ml. MRP Rs.100/- (Total-10.2 Liter & Amount Rs 1700/-)

I SI Partha Sarathi Das O/C Ashighar OP lodged a written complaint against the accused person namely Swapan Das (43), S/O- Late Rakhal Das of Purba Majahari PS Bhaktinagar Dist. Jalpaiguri to the effect that on 16.09.2021 evening as per order I along with ASI Sumit Baran Nath (1/377 Munna Ahmed and PWD 16 Amit Roy, all of Asighar OP with Govt. vehicle no WB42/R HE29 were holding raid against anti-social elements warrentes, 10 liquor etc in different area under Asighar OP as per order vide Asighar OP W.O.no 399. On 16.09.2021 in course of which I received information from my source that one Swapan Das secured a huge numbers of bottles of liquor inside his house at Purba Majahari and used to sell to the local youth in higher rates. I immediately informed I/C Bhaktinagar and as per his kind direction wasting no time I along with my accompanied party left for Purba Majahari area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Late Kalachand Ghosh of Ghogonali PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar W.no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Purba Majahari area as indicated by my source I held raid at the house Swapan Das at Purba Majahari. But seeing as the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of a one noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamoth of the case, as the above noted person as well as none could be able to produce my documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 22.40 hrs and 20.50 hrs on 16.09.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Swapan Das (43), S/O- Late Rakhal Das of Purba Majahari PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
