Respected Sir,

I, Ragini Joshi Pradhan, would like to file an F.I.R. against Mr. Pavitra Saha, owner/shopkeeper of 'Shree Bhai' shop located Near Children Park, Milanpally, on the grounds of discrimination and racism.

Mr. Saha denied selling me a ₹211 milk this morning at 9:30 a.m. at first because as I did not have cash for the milk, I saw the QR code on his shop and wanted to pay him via Google Pay. He did not want to accept the payment via an online transaction but a fellow customer agreed to make cash payment after I paid him online. As soon as he heard this, he started yelling at me and acted like I would have stolen the packet of milk. I tried to reason with him but he started hurling abuses at my friend and I in his native dialect. He said and I quote "Hum log Bengal ke log hai, tumhara Gurusung ka raj abhi nahi hai", basically implying that we Nepalis do not belong in Bengal, making a very racist comment.

I would be extremely grateful if you could look into this matter and take necessary action for the same.
