

Subject : First Information Report.

I Dr. Shankar Ghosh, MLA, Siliguri Assembly am writing you about an offence held against me to the following effects that today morning during my discharge of duty at my Assembly office Ward No. 24 of SMC local people of said ward came at my very office and expressed their complaints before me regarding irregularities in vaccination held at Jagadish Primary School (within Compound of Tarun Tirtha Club campus), North Bharat Nagar, under Ward No. 24 of SMC and accordingly when I returned from my office at around 10.45 AM I saw that under the active leading aspects of local TMC leader Bikash Sarkar (Vice President, State TMC Committee) from Ward No. 24 of SMC, the vaccination camp has been running wherein more or less 100 out sider TMC supporters gathered who most desperately continued to violate all the covid protocols and disaster management guidelines. It is to be mentioned that in the said camp, only the listed people as possessed by said one SMC official namely Rajib Majhi had been allowed for the vaccination which resulted in acute hardship for the first come first line holders of the said local ward people in general. It has been notified on the previous occasion by the SMC administration that the vaccination shall be held upon the people who have first come and shall be first served. On seeing such irregularities and malpractice, I visited at that very venue and questioned against such unethical practices and within a moment the said TMC sponsored out siders under the active instruction of above persons, cordoned me and started to threaten me with abusive languages and thereafter tried to physically assault me and also threatened me with dire consequences. During such incident, it is to be mentioned that 3 State police are present therein. On my leave, they kicked at my 2 wheeler vehicle from the behind, anyhow I managed to save myself otherwise the above miscreants are attempted their best to harm my life and limb. It is to be referred that the surrounding residential houses also have the CCTV surveillance which shall have to be procured for the identification of all the culprits involved therein.

It is really a painful blow for me and the people of Siliguri that the elected public representative has been attacked by the TMC sponsored goons under the direct instruction of ruling TMC party personnel as referred above for resisting the ill deeds of them in politicizing the Covid vaccination drive and sustain the first come first served benefits for the people at large of that very ward. Right now I have been threatened with dire consequences and the culprits behind the said act need to be detained and prosecuted at the earliest instance for creating an illustrative instance for the proper administration of Justice.
