In producing herewith the seized articles viz--

- (i) 02(two) domestic indene gas cylinder partially loaded
- (ii) 01 (one) rubber gas pipe length approx 05 (five) fit with fitted one gas regulator

In producing herewith above seized articles under proper seizure list I SI Goutam Kundu of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the Sweet Shop Styled as "Sri Balaji Sweets & Snacks", at Sukanta sarani, Milanpally, under PS- Siliguri owner namely **Raj Kishor Mandal (60) S/O Lt. Kapilaswar Mandal of Santoshi Nagar, Shyam Mandir W/NO 05, Siliguri** Sweet Shop styled as "Sri Balaji Sweets & Snacks" at Sukanta sarani, Milanpally, under PS- Siliguri Dist- Darjeeling who was illegally procured domestic Indene gas cylinder and using the domestic Gas cylinder at his sweet shop styled as "Sri Balaji Sweets & Snacks" for commercial purpose without any valid documents or license, to the effect that today i.e. 16.09.21 at 14:05 hrs I received an information from reliable source that one Raj Kishor Mandal (60) S/O Lt Kapilaswar Mandal of Santoshi Nagar, Shyam Mandir W/NO 05, Siliguri Dist- Darjeeling styled as "Sri Balaji Sweets & Snacks" at Sukanta sarani, Milanpally, under PS- Siliguri, Dist- Darjeeling is using the domestic Gas cylinder at his Sweet Shop for use commercial purpose for his wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per direction of his direction I, along with SI Pradip Chakraborty, ASI Prashanta Bardhan, ASI Ashok Biswas, C/424 Manik Roy and CV-019 Debendra Nath Roy all of EB SPC with investigation kit left for Siliguri PS vide EB SPC M.C.C No 122 /21 Dt.16.09.2021. The matters informed to Siliguri PS vide Siliguri PS GDE No 1001/21 dated 16/09/2021 along with Special K-21 van officer ASI Amar Raj Subba, C/384 Biswanath Murmu of Siliguri PS had been to Sukanta sarani, Milanpally, under PS- Siliguri to work out the information and apprised them about the information in hand and requested to accompany with us during search and seizure. As per source identification we reached at Sukanta sarani, Milanpally, under PS- Siliguri Dist- Darjeeling and entered into Sweet shop styled as "Sri Balaji Sweets & Snacks" at Sukanta Sarani, Milanpally, under PS- Siliguri Dist- Darjeeling and found that they are preparing sweets at Sweet Shop by using the domestic Indane Gas cylinder without any valid documents for commercial use on demand they could not produce any valid documents in support of using the Indane domestic gas cylinders for commercial use. **On seeing the Police party the shop owner namely Raj Kishor Mandal fled away from the shop to avoid police arrest.** Further local enquiry it is revealed that the above noted accused person was using the domestic Indane Gas cylinder for preparing sweets at his Sweet Shop as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Nitesh Mittal (38yrs) S/O Jagdish Mittal of Jatindra Mohan Sarani, Deshbandhupara PS- Siliguri, Dist- Darjeeling and (2) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the shop **Raj Kishor Mandal** used the domestic Indene cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles in presence witness namely (1) Nitesh Mittal (38yrs) S/O Jagdish Mittal of Jatindra Mohan Sarani, Deshbandhupara PS- Siliguri, Dist- Darjeeling and (2) C/424 Manik Roy of Enforcement Branch SPC after preparing proper seizure list and label duly obtained their signature. The seizure was made in between 16:15 hrs to 16:45 hrs in presence of witnesses.

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Raj Kishor Mandal (60) S/O Lt. Kapilaswar Mandal of Santoshi Nagar, Shyam Mandir W/NO 05, under PS- Siliguri, Dist- Darjeeling and owner of sweet shop styled as "Sri Balaji Sweets & Snacks" at Sukanta Sarani, Milanpally, under PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
