Sir,

In producing herewith arrested accused person namely Lila Sahani (50 yrs) W/O Late Manik Sahani of Santoshi Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 22 (Twenty two) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 22 x Rs 100/- =RS.2200/-) in which one sealed bottle has taken from mother packet as sample as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Lila Sahani (50 yrs) W/O Late Manik Sahani of Santoshi Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling to the effect that on 16.09.21 at 15.25 hrs acting on secret information, I received a source information that the above noted person was busy to sale ld liquor illegally in her house situated at Santoshi Nagar, Ward No. 05 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 998 dated 16.09.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with & LCV/ 175 Pratima Das, CV/622 Ramanath Barman left for Santoshi Nagar, Ward No. 05 under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 999 dated 16.09.21. On reaching at 15.45 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On searching - i) 22 (Twenty two) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd.

Siliguri, West Bengal @ Rs 100 each (Amounting of 20 x Rs 100/- =RS.2000/-) in which one sealed bottle has taken from mother packet as sample which was kept concealed in her house situated at Santoshi Nagar, Ward No. 05, Siliguri. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.45 hrs to 16.35 hrs. On being asked she stated that he used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Lila Sahani (50 yrs) W/O Late Manik Sahani of Santoshi Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.


