Sub:- Complain against driver of one pick up Van bearing Registration No. WB73E6102 of disobeying Traffic Signal, assaulting me while disposing Government Duty and forcefully taking me in a Go-down against my consent.

Ref:- Panitanki TG GDE no. 95, dated. 16.09.2021.

Sir,

Today (i.e, on 16/09/2021), I T/Constable No. 730 Niranjan Barman presently posted at Panitanki Traffic Guard, SPC was on duty at 09-10 Hotel Crossing at Sevoke Road. In course of my duty, in between 11:25 hrs to 11:45 hrs there was huge Traffic Congestion in the area. During Traffic congestion, one Pick up Van bearing Registration No. WB73E6102 was coming from Nabin Sen Road and intended to cross the Road through the cut-out. As the vehicle was heavily loaded and as there was heavy Traffic Congestion at that point I asked the said Vehicle to take left turn and take U Turn from Panitanki More to reach his destination for smooth flow of Traffic. Thereafter, initially the driver of the vehicle forcibly disobeyed my signal and forcibly tried to cross the road. When I tried to stop and detain him he physically assaulted me and pulled the collar of my Uniform and broke his looking glass by himself and tried to instigate the other public against me by raising false allegation of breaking the looking glass of his vehicle. I then called ASI Sujoy Sarkar of Panitanki Traffic Guard who was on round in that area over phone to deal with the incident. As there was huge Traffic congestion the said on duty officer directed the vehicle to park his vehicle at Sevoke More for checking the valid documents of the said vehicle and asked me to accompany him. Accordingly, I boarded the vehicle and then the driver suddenly started his vehicle, raised the pickup of his vehicle and carried me forcefully in a Go-down at Sevoke Road named "Everest Steel" instead of Sevoke More as directed. When I shouted the driver left me in the vehicle at the same Go-down and fled away. There after ASI Sujoy Sarkar reached the spot and locked the vehicle.

Under the circumstances, I would appeal you to take necessary legal action in this regard and register a specific case against the driver of the said vehicle and all concerned for the offences committed. The area where the incident occurred is within the coverage of CCTV of Traffic Control Room and may kindly be perused.
