In producing herewith arrested accused person namely Manaranjan Das @ Manu (50 yrs) S/O Late Nikunja Das of Rabindra Nagar, Anari more, Ward No. 21, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 21 (Twenty one) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 21 x Rs 100/--RS.2100/-) in which one sealed bottle has taken from mother packet as sample as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused Manaranjan Das @ Manu (50 yrs) S/O Late Nikunja Das of Rabindra Nagar, Anari more, Ward No. 21, PS-Siliguri, Dist-Darjeeling to the effect that on 16.09.21 at 20.40 hrs acting on secret information, I received a source information that the above noted person was busy to sale id liquor illegally in his house situated at Rabindra Nagar, Anari more Ward No. 21 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1020 dated 16.09.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with CV/283 Prosenjit Dey ,CV/622 Ramanath Barman left for Rabindra Nagar, Anari more under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 1021 dated 16.09.21. On reaching at 21.05 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the

ASI Sibun Sarkar Silyuni ps/spc. above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - - i) 21 (Twenty one) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 21 x Rs 100/- =RS.2100/-) in which one sealed bottle has taken from mother packet as sample which was kept concealed in his house situated at Rabindra Nagar, Anari more, Siliguri. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 21.35 hrs to 22.25 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Manaranjan Das @ Manu (50 yrs) S/O Late Nikunja Das of Rabindra Nagar, Anari more, Ward No. 21, PS-Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
