In producing here with the seized articles viz:-

- (i) 03(three) nos HP Gas Cylinder partially loaded (domestic)
- (ii) 01(One) no. Indian Gas Cylinder fully loaded (domestic)
- (iii) 01(one) gas Oven
- (iv) 01 (one) gas pipe length about 05 (five) fit with fitted one gas regulator

In producing herewith above seized articles under proper seizure list, I SI Goutam Kundu of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the owner namely Ananda Ghosh (32) S/O Lt. Nirendra Nath Ghosh owner of Hotel Styled as "New Chalachal Hotel" situated at Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling. Who was illegally procured the domestic Gas cylinder at his Pice Hotel styled as "New Chalachal Hotel" for commercial purpose without any valid documents or license to the effect that today i.e. 16.09.21 at about 13.25 hrs received an information from reliable source that one Ananda Ghosh (32) Lt. Nirandra Nath Ghosh of Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling is using the domestic Gas cylinder at his Pice Hotel Styled as "New Chalachal Hotel" for use commercial purpose for his wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per his direction I, along with SI Pradip Chakraborty, ASI Prashanta Bardhan, ASI Ashoke Biswas, C/424 Manik Roy and CV-019 Debendra Nath Roy all of EB SPC with investigation kit left for Matigara PS vide EB SPC M.C.C No 121 /21 Dt 16.09.2021. The matters informed to Matigara PS vide Matigara PS GDE No. 868 Dt 16.09.2021 along with van officer ASI Avijit Chanda, C/227 Samir Sarkar, C/585 H N Roy of Matigara PS had been to Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source identification we reached at "New Chalachal Hotel" situated at Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling and entered into Pice Hotel styled "New Chalachal Hotel" at mentioned address and found worker of hotel are cooking foods at Hotel by using the domestic HP and Indane Gas cylinder without any valid documents for commercial use. on demand they could not produce any valid documents in support of using the HP and indane domestic gas cylinders for commercial use. Ananda Ghosh (32) S/O Lt. Nirendra Nath Ghosh of Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling manage to fled away from the Hotel to avoid police arrest. Further local enquiry it is revealed that the above noted accused person was using the domestic HP and Indane gas cylinder for preparing food at his Hotel as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Suklal Bala (33) S/O Sridam Bala of Haribosh, Fulbari, PS-Ghoksadanga dist- Cooch Behar (2) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the Hotel namely Ananda Ghosh using the domestic HP and indane gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles in presence of witnesses namely (1) Suklal Bala (33) S/O Sridam Bala of Haribosh, Fulbari, PS-Ghoksadanga dist- Cooch Behar and (2) C/424 Manik Roy of Enforcement Branch SPC. after preparing proper seizure list and label duly obtained their signature. The seizure was made in between 14.35hrs to 14.55hrs in presence of witnesses.

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Ananda Ghosh (32) S/O Lt. Nirendra Nath Ghosh of Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling owner of Pice Hotel Styled as "New Chalachal Hotel" situated at Shibmandir Bazar, beside NH 31 over bridge, Kadamtala, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
