Myself Puranjan Nandi, Son of Late Fakir chandra Nandi, resident of Khaprail, Post Office New Chamta, Police Station-Matigara, District - Darjeeling, beg to submit as follows:

That my wife, Bilashi Lakra (since deceased), Daughter of Doud Lakra was the recorded owner in possession of the land measuring 0.50 Acre in L.R.Khatian No.99 appertaining to and forming part of LR.Plot No.345 at Mouza - Khopalashi, J.L.No.21, Police Station - Matigara, District - Darjeeling, having permanent, heritable and transferable right title and interest therein.

Since my neighbour Radha kishore pathak, Dhruv pathak, Debendra Pathak, tried to encroach and construct on my land in the year 2000 myself went to the court for judgement. (Title suite no-162 of 2000.)

In the year 2015 i got decree in favour of me but Pathak and other again filed for review. Therefore i am waiting for further judgement.

Yesterday i observed they are doing construction on the disputed land. Immediately myself requested to stop such construction till final judgement. But they are not listening and continuing the construction forcibly. In this situation i shall be thankful if you kindly take suitable action to stop this illegal construction.
