Respected Sir,

With due respect I Smt. Nandita Roy, W/o Bipur Singha, D/o Mintu Roy presently residing at Rangia Rangia, Vill - Purba Rangia, GP - Atharakhai, Block - Matigara, P.O. New Rangia, P.S. Matigara, Dist. Darjeeling, Pin - 734013, would like to draw your kind attention to the following effect that our marriage was solemnized of 28.02.2020 at Kawakhari, Medical More, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling under Section 13 of ACT XLIII of 1954 in presence of parents, friends, relatives and well wishers of both parties but after marriage my husband alongwith my aforesaid in-laws created pressure upon me for Pulsar bike, TV, fridge, Gas oven, furniture and cash Rs. 1 lack. Accordingly my parents gave me one pulsar 150 bike to my husband in the month of November, 2020 and my parents celebrated a party on the eve of my marriage on 10.12.2020 and at that time my parents also handed over Rs. 1 lack in the hands of my father-in-law and gave gold ornaments as per the capacity of my father and khat, dressing table, steel almirah, suitcase, alna, ply mitcase, trunk, sofa set, dinner table with 4 chair, dinner set, 32" Samsung TV, Samsung fridge, stand fan, gas oven with cylinder, 3 pic blanket big size, 5 number of pressure cooker, utensils of Kasha, pital and steel, kalshi of pital, 150 pic Sharee, Beddings and other materials. After inception of my matrimonial home the aforesaid persons again started to torture upon me physically and mentally for want of more dowry, as a result I 3/4 times took shelters to my parental home out of fear of them. Thereafter my husband asked apologized and took me in my matrimonial home again with a promise not inflicted any kind of torture upon me but he did not keep his promise. With the instigations of my in-laws my husband became more violent and several times tried to kill me. The look of my father-in-law towards me is not good as such I several time narrated the same to my husband but all are in vain and they tried to give me stigma that I am an insane person. Ultimately I conceived but thereafter the degree of torture gradually increased to kill my unborn baby and on 04.08.2021 in night time my husband with the instigations of my in-laws severe tortured my physically and mentally to abort my unborn child, finding no other alternative I called my elder brother Subhajit Roy, accordingly who came on 05.08.2021 and brought me in my parental house and since then I am living in my parental house to save my pregnancy. It is pertinent to mentioned here that my husband and my in-laws did not provide me proper food, medicines etc. Some unintentional delay is appeared to lodge this complaint because I think good sense of my husband will be arise and my marriage tie keep well, but my husband did not look after my welfare and not provide any medical expenses whereas I am pregnant of 5 months.

In view of above you are requested to take proper legal step against the aforesaid persons as per law.
