In producing herewith four (04) arrested accused persons namely (i) Sagar Rajbansi (21) S/O Ujjal Rajbansi of Ektiasal, PO+PS Bhaktinagar, Dist - Jalpaiguri (ii) Sanjay Rajbansi (22) S/O Chimanto Rajbansi of Champasari, PO Champasari, PS Pradhan Nagar, Dist- Darjeeling, and (iii) Md. Alamgir (21) Md Alam of Matigara Baazar, P.O + P.S- Matigara, Dist- Darjeeling, (iv) Manik Roy (37) s/o Krishna Roy of Biswas Colony, P.O + P.S- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made Spade measuring 28 inch (approx) in length from the possession of Sagar Rajbansi which was kept on his right hand,
- (2) One iron made sword measuring 30 inch (approx) including wooden handle from the possession of Sanjay Rajbansi which was kept concealed on his back side
- (3) One iron made 'Katari' measuring 26 inch (approx) including wooden butt from the possession of Md. Alamgir which was kept concealed on his back side,
- (4) One Iron Rod measuring 27 inch (approx) including wooden handle from the possession of Manik Roy which was kept on his left hand.

I, PSI-Abhishek Theengh (32) S/O Suchandra Kumar Theengh of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Sagar Rajbansi, (ii) Sanjay Rajbansi (iii) Md Alamgir, (iv) Manik Roy and others to the effect that today on 16.09.2021 at 22.25 hrs received a sources information that 10/12 youths have assembled near Siliguri New Gate under Matigara PS with a view to commit dacoity at that area. The fact was diarized in GDE vide Matigara PS GDE No 888 dated 16.09.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, ASI Nitai Ch. Mandal, C/986 Rajib Sarkar, C/1035 Santosh Rabidas and CV/387 Sukumar Barman left for the place to work out the information.

At about 22.55 hrs after reaching near Siliguri new Gate under PS- Matigara, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above noted four (04) accused persons namely Sagar Rajbansi, Sanjay Rajbansi, Md. Alamgir, Manik Roy along with seized articles from their possession as mentioned above. However the other persons namely Ritik Sarkar, Kaushik Barman, Kartik Sarkar and others managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Gas Godown area.

I thereafter, seized the above noted weapons under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole seizure was made in between 23.05 hrs to 23.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Gas godown area. It is also revealed from them that few others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons namely (i) Sagar Rajbansi (21) S/O Ujjal Rajbansi of Ektiasal, PO+PS Bhaktinagar, Dist - Jalpaiguri (ii) Sanjay Rajbansi (22) S/O Chimanto Rajbansi of Champasari, PO Champasari, PS Pradhan Nagar, Dist- Darjeeling, and (iii) Md. Alamgir (21) Md Alam of Matigara Bazaar, P.O + P.S- Matigara, Dist- Darjeeling (iv) Manik Roy (37) s/o Krishna Roy of Biswas Colony, P.O + P.S- Matigara, Dist- Darjeeling.
