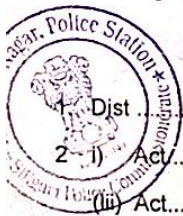

Respected Sir,

I Sanjay Yadav son of Jagdip Yadav, resident of Mallaguri, Behind Hill Point Clinic, P.O & P.S Pradhan Nagar, Siliguri Dist: Darjeeling.

I beg to report you that today at about 02:40pm, it came to my knowledge that the owner of Dipu Garrage and his associates namely 1. Dipu Chowdhury son of Unknown, 2. Babu Chowdhury son of Unknown 3. Pradip Chowdhury son of Unknown, all are resident of Mallaguri, and 4. Mrinal Chakraborty son of Unknown, resident of B.B.D. Colony, and also the workers of the said garage, were illegally occupying the vacant land which has been abandon from last 30 years and the local residents of the area uses the said land to perform occasional Puja's like Durga Puja, Kali Puja and any other functions and also the local children play in that vacant land.

Now when I and one of my friend namely Ramesh Barman son of Late. Rajen Barman, resident of Mallaguri tried to stop the above named persons from illegally occupying the said land then they started using unparliamentarily words towards us and have also hit us with fist and blows and one of the above noted person also snatched my gold chain from my neck and one of the associates had also brought one iron rod from the garage and attacked us with an intention to kill us, because of which me and my friend have been injured very badly and somehow we were able to escape from the clutches of the above named persons. And the above named persons have also threatened us that we have to face dire consequences if we interfere in this matter again.

Therefore I request you to kindly take serious action against the above noted persons and help me and my friend with Justice.
