Respected Sir, I Siddharth Bhattacharya, s/o Rajendra, Bhattacharya, resident of Gali NO 2, Sripath, Methibari - 734009, came to Siliguri from Darjeeling today i.e. 11/9/2021 and to my astonishment I found that the main lock of my front door was broken. When I entered inside my premises all the household items were littered and scattered away. The almirah in which I had kept my clothes and valuables were broken down. I had golden ornaments amounting to around 6 tolas which is missing, my school and college documents were scattered from the shelf and some other documents are still not accountable. I had four watches which has also been stolen, Cash amounting to Rs 17,000 has also been stolen along with stove and my gas cylinder.

I had come around 6 pm when to my horror I found out that my house was vandalised and all important items were stolen.

I would kindly request you to look into this matter so that the culprits can be apprehended at the earliest.
