Subject: A complaint letter regarding physical assault and violence on the road by the miscreants.

Respected Sir/Madam,

With due respect this is to inform you that three buses (WB73C5775, WB694757, WB 73E1783) carrying approximately 150 Nursing students along with faculties was stopped at Mallaguri near Sani Mandir Ghora More area by few miscreants who have erected a puja pandal nearly blocking the road. When the driver requested the way of passage, the miscreants attacked and physically assaulted our bus conductor Mr. Jotish Das, son of Mr. Niren Das without any provocation on our side. The girls and the faculties were extremely alarmed and terrified by the violent beating of the conductor. Furthermore, often these miscreants are drunk and sit at this point of the road and pass threatening comments at our students and teachers when they pass through this road. We are extremely insecure about the safety of our staffs, students and teachers.

Therefore, I want to report an FIR and hope strict action will be taken against the perpetrators and assurance of the future safety and hope any counter action will not happen from their side in regard to this complaint.
