In producing here with **five** arrested persons namely, (1) Sanu Paul(24) S/O Kamal Paul of Champasari, Kadamtala, Pokajote, Ps. Pradhan Nagar, Dist-Djg (2) Rahul Rana(19) S/O Raghu Rana of Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (3) Manish Munda(19) S/O Munshi Munda(19) of Balubusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (4) Chandan Sah(19) S/O Lt. Ramesh Sah of Nayabusty, Salbari, Ps. Pradhan Nagar, Djg, (5) Akash Munda(18) S/O Lt. Joy Munda of Nayabusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, along with seized articles viz (i) One Iron Sword with pointed tip and sharp edges length measuring approx 2'ft 9.5" inches including butt (in which metal made butt length measuring approx 9.5" inches), (ii) One Hammar with wooden stick length measuring 10" inch, (iii) One Iron Rod length measuring approx 2'ft 8" inch (iv) One iron rod length measuring approx 2'ft (v) One Iron 'Chheny' measuring approx 9.2" inches, (vi) One Iron rod measuring approx 2'ft, (vii) One black colour rechargeable torch light in which yellow border along with seizure list and connected papers.

I PSI. Chetan Dangal of Pradhan Nagar Ps/SPC do here by lodged the complaint against the above miscreants that, Today i.e. 12.09.21 at about 23:45 hrs received an information from credible source that 12/14 miscreants armed with deadly weapons assembled at Ambadhura math beside Panchnoi river side under Pradhan Nagar Ps area and preparing themselves to commit 'Dacoity' at Aghamsingh Nagar, near DPS under Pradhan Nagar Ps area against property and vehicle. After receiving this information I informed the matter to on duty officer as well as I/C Pradhan Nagar PS. The On Duty Officer diarized the information in GDE vide Pradhan Nagar PS GDE No- 690, Dated- 11.09.21 and as per direction of I/C Pradhan Nagar PS myself along with SI. Haren Kr. Mohanta, SI. Binup Mohanta, ASI. Ratan Pradhan, CV645 Pankaj Gupta, CV 223 Swapan Chetri proceeded to the place to work out the information, I also informed the R.T. Mobile Officer to assist us. R.T. Mobile Officer ASI. Suresh Kami and Const/476 Jagat Ch. Roy proceeded for assisting us.

At about 00:05 hrs we reached near Ambadhura and met with my source there and he corroborated the information again. Afterwards we proceeded towards the spot on foot and found 12/14 persons were sitting at Ambadhura Math and seeing the uniformed police party they tried to flee away but we managed to apprehended 05(five) persons out of them and the apprehended persons disclosed the identity of themselves as, (1) Sanu Paul(24) S/O Kamal Paul of Champasari, Kadamtala, Pokajote, Ps. Pradhan Nagar, Dist-Djg (2) Rahul Rana(19) S/O Raghu Rana of Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (3) Manish Munda (19) S/O Munshi Munda(19) of Balubusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (4) Chandan Sah(19) S/O Lt. Ramesh Sah of Nayabusty, Salbari, Ps. Pradhan Nagar, Djg, (5) Akash Munda(18) S/O Lt. Joy Munda of Nayabusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling along with 7/8 other miscreants who managed to flee away. After their apprehension we have disclosed our identity to them as the officer and men of Pradhan Nagar PS. On being asked they disclosed that they assembled there and preparing them to commit Dacoity at Agham Singh Nagar Colony under this Ps. There after observing all formalities I conducted search of the apprehended persons. During search, I found in the possession of (1) Sanu Paul(24) found one Iron Sword with pointed tip and sharp edges length measuring approx 2'ft 9.5" inches including butt (2) Rahul Rana(19) found one Hammar with wooden stick length measuring 10" inch, (3) Manish Munda (19) found one Iron Rod length measuring approx 2'ft 8" inch and one Iron 'Chheny' measuring approx 9.2" inches, (4) Chandan Sah(19) found one Iron rod measuring approx 2'ft (5) Akash Munda(18) found one black colour rechargeable torch light in which yellow border. On demand they failed give any satisfactory answer for presence and possessing those illegal weapons in the darkness. Those were seized from their possession in between 00:25 hrs to 01:15 hrs under proper seizure list duly signed by the police witnesses as no public witness available there at that time of night. The seized articles were also labeled and sealed on the spot and arrested the above noted apprehended persons after observing all norms of NHRC and Hon'ble Supreme Court of India for possessing illegal weapons and preparation of Dacoity, issuing Memo of Arrest after that conducted raid in criminal den and adjacent area to apprehend the other associates leading to their statements. Then I brought the accused persons to Pradhan Nagar PS and produce before duty officer along with all seized articles and relevant papers.

Therefore, I pray before you that a case U/S- 399/402 IPC may kindly be started against the miscreants namely (1) Sanu Paul(24) S/O Kamal Paul of Champasari, Kadamtala, Pokajote, Ps. Pradhan Nagar, Dist-Djg (2) Rahul Rana(19) S/O Raghu Rana of Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (3) Manish Munda (19) S/O Munshi Munda(19) of Balubusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, (4) Chandan Sah(19) S/O Lt. Ramesh Sah of Nayabusty, Salbari, Ps. Pradhan Nagar, Djg, (5) Akash Munda(18) S/O Lt. Joy Munda of Nayabusty, Salbari, Ps. Pradhan Nagar, Dist-Darjeeling, along with 7/8 other miscreants and arrange for its investigation.
