In producing herewith one arrested accused person namely Prosenjit Adhikary(34) s/o-Nayan Adhikary of Bhagajatin Colony, Purbanchal, W/N-02 near Radha Gobinda Mandir PS-Pradhannagar Dist-Darjeeling along with the following articles under seizure:

I, SI Biswajit Ghosh of Detective Department, SPC do hereby lodge this written complaint against the arrested accused person namely Prosenjit Adhikary(34) s/o-Nayan Adhikary of Bhagajatin Colony, Purbanchal, W/N-02 near Radha Gobinda Mandir PS-Pradhannagar Dist-Darjeeling to the effect that on 12.09.21 at 18.05 hrs received an information that an online gambling is going on inside a room situated at Champasari More beside Hotel Mahananda under Pradhannagar PS area. Accordingly I informed the matter to ACP, DD, SPC and as per his kind direction myself along with SI. Tamzit Ali, ASI. Abu Taleb, C/371 Sushanta Dey, C/682 SK Sabrati all of D.D, SPC left for the spot to verify the veracity of the information vide D.D, SPC GDE No-57/21 dt-12.09.21

At 18.45 hrs on reaching the spot and found that the above noted arrested accused person is playing online lottery through computer for prize through internet connection to some customers, seeing the police party the customers flee away from the said room. However we apprehended above noted arrested accused person namely Prosenjit Adhikary(34) s/o-Nayan Adhikary of Bhagajatin Colony, Purbanchal, W/N-02 near Radha Gobinda Mandir PS-Pradhannagar Dist-Darjeeling. On being asked the said person failed to produce any valid document in support of the said gambling using internet access. On being searched the spot the above noted gambling articles are found lying there. Accordingly I seized all the above noted articles in presence of witnesses namely (i) Partha Das(54) s/o-Lt Dharani Mohon Das of Champasari near child school PS-Pradhannagar Dist-Darjeeling (ii) Niranjan Ghosh(63) s/o-Lt Paresh Ghosh of Champasari more PS-Pradhannagar Dist-Darjeeling under proper seizure list. The seizure was made from 19.05 hrs to 19.55 hrs and arrested the above noted accused person after issuing memo of arrest and appraising the ground of arrest.




