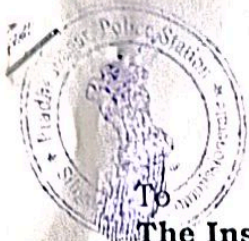

Sir,

I, PSI Chetan Dangal presently posted at Pradhan nagar Police Station, SPC would like to lodge this written complaint against two (02) arrested accused person named 1) Kamal Pandit (22), S/O- Lalji Pandit of Rajendra nagar, Coolie para, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling, 2) Shivam Mishra (19), S/O- Manoj Mishra of near Mallaguri Petrol Pump, P.S.- Pradhan nagar, Dist- Darjeeling, P/A Batnaha, P.S.- Batnaha, Dist- Sitamari, Bihar, who were arrested for contravening the norms of NDPS Act and also produced the following seized articles under seizure, as per seizure list:

- i) 27 (twenty seven) bottles of REXDRYL Cough Syrup, from inside of black colour medium size carry bag, marked as Exhibit-A, seized from accused Kamal Pandit.
- ii) 02 (two) bottles of REXDRYL Cough Syrup taken from Exhibit -A as sample marked as Exhibit A-1.
- iii) 24 (twenty four) bottles of REXDRYL Cough Syrup, from inside of red colour medium size carry bag, marked as Exhibit-B, seized from the accused Shivam Mishra.
- iv) 02 (two) bottles of REXDRYL Cough Syrup taken from Exhibit -B as sample, marked as Exhibit B-1.

In this regard I beg to state that today i.e. on 13.09.2021 at about 18.35 hrs myself received a secret source information that two persons is standing in front of Tenzing Norgye Bus Terminus, near Siliguri Junction carrying huge quantity of Contraband syrup in their possession. Accordingly I shared the information with you and as per your kind direction at 18.45 hrs myself along with PSI Kalyan Saha, ASI Ratan Pradhan, ASI Ashit Singha, CV-223 Swapan Chhetri, CV-128 Ajay kumar Sahani all of Pradhannagar PS, SPC left for Tenzing Norgye Bus Terminus to verify the veracity of the information vide Pradhannagar P.S. GDE. No. 805, Dt- 13.09.2021. At about 18.50 hrs we arrived at Tenzing Norgye Bus Terminus, near Siliguri Junction and called two independent witnesses namely 1) Bishal Roy (20), S/O- Bablu Roy of Dagapur, near DFS School. P.S.- Pradhan nagar, Dist- Darjeeling, 2) Chotu Paswan (25), S/O- Lt Dipak Paswan of Coolie para, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. As identified by the source we apprehended the persons namely 1) Kamal Pandit (22), S/O- Lalji Pandit of Rajendra nagar, Coolie para, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling, 2) Shivam Mishra (19), S/O- Manoj Mishra of near Mallaguri Petrol Pump, P.S.- Pradhan nagar, Dist- Darjeeling, P/A Batnaha, P.S.- Batnaha, Dist- Sitamari, Bihar. Thereafter I gave them the option to be searched before a Magistrate or a Gazetted Officer upon which they agreed to be searched before a gazette officer and I also gave them a written information in this regard and accordingly they gave consent verbally.

Consequently, I contacted with Sri Subasisi Chaki ,I/C Pradhannagar P.S. SPC for come to the spot and supervise the entire process of search and seizure. Sri Subasisi Chaki, I/C P.S., SPC arrived at the spot at 19.10 hrs, thereafter the process of the search was started. Before conducting search self search of me and Sri Subasisi Chaki ,I/C Pradhannagar P.S., SPC had been conducted by the detained person and a memo had been given to them to the effect that and he could not find any other offending things except arms and IO kit.

On search their bags which was carrying by the apprehended persons, I recovered i) 27 (twenty seven) bottles of REXDRYL Cough Syrup, from inside of black colour medium size carry bag, marked as Exhibit-A, seized from accused Kamal Pandit and ii) 24 (twenty four) bottles of REXDRYL Cough Syrup, from inside of red colour medium size carry bag, marked as Exhibit-B, seized from the accused Shivam Mishra. On demand the apprehended persons could not produce any documents in respect of the recovered Cough Syrup. On asked they also started making different causes of possessing the said contraband cough syrups.

Thereafter, in presence of the I/C Pradhan nagar P.S. and independent witnesses, I seized the above noted articles as alamat in c/w this case. The seizure has made between 19.20 hrs to 20.35 hrs from the possession of the accused persons namely 1) Kamal Pandit and 2) Shivam Mishra, by preparing a seizure list duly signed by the independent witnesses & accused person. In the seizure list I obtained the signature of Sri Subasish Chaki ,I/C Pradhan nagar P.S., SPC and also put signature including me. Consequently, the apprehended above noted persons has been arrested by me at 20.45 hrs by issuing a proper Arrest Memo for contravening the norms of NDPS Act and returned back to Pradhan nagar P.S. at 20.55 hrs.

In the above circumstance, I pray before you to take the seized articles and sample and the arrested accused 1) Kamal Pandit (22), S/O- Lalji Pandit of Rajendra nagar, Coolie para, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling, 2) Shivam Mishra (19), S/O- Manoj Mishra of near Mallaguri Petrol Pump, P.S.- Pradhan nagar, Dist- Darjeeling, P/A Batnaha, P.S.- Batnaha, Dist- Sitamari, Bihar, started a specific case against the arrested accused person under appropriate section of law and arrange for its investigation
