In producing herewith two arrested accused persons namely (1) Dipankar Mallik (29) S/O Lt. Upendra Nath Mallik of Dashrathpally near Mungti Preinchand College, Ps. Bhaktinagar, Sevoke road, Dist-Jalpaiguri, (2)Guddu Ram(31) Lt. Syamarayan Ram of Cooliepara,W/No. 1,Ps.Pradhan Nagar /Dtg along with following seized articles:-

- (1) 15.450(kgs) four hundred & fifty gm)Kg approx said to be ganja wrapped with brown colour cello tape from a big size plastic gunny bag (red & white colour) mother packet marked as Exhibit "A" from which 50gm said to be ganja extracted as sample marked as Exhibit "A-1"
- (2) 6.210(kgs) Two hundreds and sixty gm)approx said to be ganja wrapped with brown colour cello tape from a big size plastic gunny bag (red & white colour) mother packet marked as Exhibit "B" from which 50gm said to be ganja extracted as sample pack and marked as Exhibit "B-1"
- (3) One big size plastic gunny bag in which seized articles Min. 1 & 2 kept was concealed for easier disposal

(Total 21.660)kg said to be ganja was recovered from the exclusive joint possession from both the accused persons as noted above which was kept concealed in a big size plastic bag carrying by the accused persons.

SI. Haren Kumar Mohanta presently posted at Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused persons who have been arrested for contravening the norms of NDPS Act to the effect that today on 16.09.21 at 11.05 hrs myself received a secret source information that two person are possessing and carrying one big size bag with a huge quantity of Ganja inside the bag with a view to transport and sale the same in Patna, Bihar, prepared from Assam, they could be caught red handed, I apprehended immediately. Wasting no time I dialed the information to Pradhan Nagar PS GDC No. 968 Dated 16.09.21 and informed the matter to you for kind instruction. Subsequently on being direction, myself along with SI Binod Mallick, PSI Chiran Dangal, ASI Baran Pradhan, CV/22, Swapnil Chettri and CV/242 Rakesh Mangal left PS along with investigating lots i.e. the weighing articles, envelope, gun seal etc from Pradhan Nagar PS at 11.15 hrs for pursuing the information by Govt. Vehicle bearing regd. no. WL 74 9951. This refers to Pradhan Nagar PS GDC No. 969 Dated 16.09.21 and MCC No. dt 16.09.21 under the circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. While going to Bihar Bus Stand near Silguri Tenzing Norgay Bus Terminus, we contacted two persons namely (1)Sara, Sha (19) S/O Birju Sha of Rajendra Nagar Coolie para, Ps Pradhan Nagar,District Parkaj Yadav[19] Munna Yadav of Rajendra Nagar Coolie para,Ps Pradhan Nagar,Dist-Ptg who were present there and make them aware of the information in hand and requested them to act as witnesses if any search and seizure would be made, which they agreed and I gave them more in this regard. Thereafter we along with the independent witnesses reached at Silguri Tenzing Norgay Bus Terminus at 11.25 hrs.

On reaching there I contacted with my source and subsequently on being pointed by my source we cordoned off two persons who were possessing one big size bag both holding and dragging the bag at Tenzing Norgay Bus Stand under Pradhan Nagar PS to ride Bihar Going bus. Thereafter we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. As the door of ganja was coming out from the gunny bag, of their possession there was enough reason to believe that the article inside the Plastic bag were ganja. Subsequently on being asked they disclosed their Identity as noted above and thereafter, I gave him the written option to be searched before a Magistrate or a Gazetted Officer upon which they agreed to be searched before any gazetted officer. Subsequently I contacted to the I/C Pradhan Nagar PS Sri. Subhasish Chakraborty and stated him about the fact and requested him to be present at the spot as Gazetted officer for supervising search and seizure in presence of witnesses. Sri Subhasish Chakraborty, I/C PDN PS arrived at the spot at 11.35 hrs and thereafter the process of the search was conducted. Before conducting the search full search of mine and Sri Subhasish Chakraborty had been conducted by the witnesses. Subsequently on being searched from the gunny bag of the above noted accused person said to be ganja could be recovered. Thereafter I weighed the ganja recovered from the accused person which stands total 21.660 kgs. Thereafter I seized the recovered Ganja under proper seizure list duly signed by the accused persons and witnesses. The seizure was made in between 12:15 hrs to 13:45 hrs. In the seizure list I obtained the signature of accused persons, Sri Subhasish Chakraborty, I/C Pradhan Nagar PS as gazetted officer, witnesses and put my signature too. Two mother packets have been labeled as "A", "B" and took out samples of 50 grams from each mother packets and marked as "A-1", "B-1" respectively. Then the apprehended persons were arrested after issuing Arrest Memo for contravening the norms of NDPS Act and returned back to Pradhan Nagar Ps.

On the above circumstance, I pray before you to start a specific case against the above noted accused person namely (1) Dipankar Mallik (29) S/O Lt. Upendra Nath Mallik of Dashrathpally near Mungti Preinchand College, Ps. Bhaktinagar, Sevoke road, Dist-Jalpaiguri, (2)Guddu Ram(31) Lt. Syamarayan Ram of Cooliepara,W/No. 1,Ps.Pradhan Nagar /Dtg under proper section of law and arrange for its investigation.
