- All the articles packed in one big nylon bag.


I beg to report that I, SI Prakash Saha of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Sangam Lama-32yrs s/o Raju Lama of Samarnagar, Simulguri, PS Pradhan Nagar Dist Darjeeling to the effect that on 17.09.21 at 18.05 hrs received a source information from Ektiasal, Pradhan More ward No-40 under Bhaktinagar PS that one person namely Sangam Lama were standing Pradhan More under Bhaktinagar PS with huge quantity of liquor for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-809 dated 17.09.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 18.35 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 28.40hrs to 19.10hrs)

I therefore request you a specific case may kindly be started against the accused person namely Sangam Lama-32yrs s/o Raju Lama of Samarnagar Simulguri PS Pradhan Nagar Dist Darjeeling under proper section of law and arrange for investigation.
