Sir,

In producing herewith the arrested accused persons namely (i) Jayanta Barman (25), Rathindra Barman, of - Tari Jote, Jyotirmoy Colony, PO - New Rangia, PS - Matigara, Dist - Darjeeling, (ii) Monilal Roy (51), S/O - Late Tulsi Roy, of - Promod Nagar, PO - New Rangia, PS - Matigara, Dist - Darjeeling, (iii) Madan Bhowmik (37), S/O - Late Arun Bhowmik, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (iv) Binod Dangal (35), S/O - Lami Dangal, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (v) Jhantu Das (55), S/O - Sailen Das, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling, (vi) Ujjal Bhaduri (40), S/O - Khokan Bhaduri, of - Thiknikata, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling arrested u/s 41 Cr.PC do hereby lodge a written complaint against them.

In this regard, I beg to state that on 18.09.2021 about 17.35 hrs while performing special mobile duty vide GDE No. 550 Dtd: 18.09.2021, received information that some people are violating the order of Lockdown and roaming aimlessly without wearing face mask at Chathat Medical More without wearing face mask. Informed O/C, Matigara PS and as per his direction, I along with force and had been to Chathat Medical More under NBMC OP and arrested the above noted six accused persons. They are completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 618-ISS/2M-22/2020 DTD.30/04/2021 and 622-ISS/2M-22/2020 DTD. 1st May 2021 issued by the Ministry of Health & family Welfare, Government of India Order no. 403/2020-DM-1(A) Dtd.29/04/2021 and Order No.647-ISS/2M-22/2020 DTD.15/05/2021. On seeing police, they tried to flee away but somehow, the above noted persons could be apprehended. On interrogation, they disclosed their name and address as noted above. On further interrogation, they admitted that they were aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As they has violated the Lockdown Order promulgated by the appropriate Government Authority and also the provision of Disaster Management Act, 2005, I with the help of force arrested them U/S 41 CrPC by issuing them memo of arrest.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused persons.
