In producing herewith one arrested accused person namely Dilip Das (35) S/O Bimal Das of Gouranga Pally, Near Tin Gach, Haiderpara, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri, along with seized articles (I) 20 (Twenty) Bottles of 60 UP Country Spirit styled as GALAXY BOSS measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01.

I, ASI Gazi Rahaman of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 18/09/2021 at 16:35 hrs during special raid duty I received secret source information that, one person is selling huge quantity of country spirit at Sevoke Road Near Amar Garage, under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with SI Arindam Chatterjee, C/1036 Gopal Srivastav, C/576 Binay Ch Roy & CV-1009 Monoj Thakur left for PO to work out the information. On arrival at Sevoke Road Near Amar Garage, Siliguri at 16.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Gouranga Pally, Bhaktinagar adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered [i) 20 (Twenty) Bottles of 60 UP Country Spirit styled as GALAXY BOSS measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the serzed articles SL No- 01.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 20 (Twenty) Bottles of 60 UP Country Spirit styled as GALAXY BOSS measuring 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 16:55 hrs to 17:25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 2000/-
