Sir,

I, ASI Ratan Pradhan of Pradhan nagar, no P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one secret person namely Arjun Roy(53) S.O Lt Nathni Roy of Maldiapuri, P.S. Pradhan nagar, Dist- Darjeeling along with 21 (Twenty one) bottles of Himalayan Gold Gthrop Country Spirit containing 600ml each and 10(Ten) pouch of Officer Choice, Each pouch containing 180ml, which has been seized under proper seizure list, enclosed herewith), to the effect that on 18.09.2021 at 19.10 hrs I received a secret source information that one person namely Arjun Roy is selling illegal liquor through his stall at Mallaguri. Accordingly I informed the matter to the PC Pradhan nagar P.S., SPC and as per his kind direction myself along with, ASI Ashit Singhra, CV-128 Ajay Kumar Saham, CV-223 Sapna Chettri all of Pradhan nagar P.S. left for Samat nagar to verify the veracity of the source information vide Pradhan nagar P.S. GDE No 1117 Dated 18.09.2021 at 19.10 hrs. On reaching at the spot at 19.20 hrs and after being confirmed by the source, I apprehended one person namely Arjun Roy(53) S.O Lt Nathni Roy of Mallaguri, P.S. Pradhan nagar, Dist- Darjeeling. On interrogation it was learnt that since a long time he was selling illegal liquor to public, without any document or valid license for his illegal gain. Accordingly, search has been conducted and from inside the stall I recovered 21 (Twenty one) bottles of Himalayan Gold Gthrop Country Spirit containing 600ml each, and 10(Ten) pouch of Officer Choice, Each pouch containing 180ml. On demand said Arjun Roy failed to produce any such document in respect of recovered liquors. It is a violation under Bengal Excise Act. Accordingly seized the said Liquors from the apprehended person, under proper seizure List duly signed by them and the witness set. This seizure was made in between 19.25 to 20.05 hrs. As a result I arrested the accused person Arjun Roy(53) S/O Lt Nathni Roy of Maldiapuri, P.S. Pradhan nagar, Dist- Darjeeling, after preparing memo of arrest and intimating the ground of arrest. At 20.10 hrs the arrested accused person along with seized articles has taken to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Arjun Roy(53) S/O Lt Nathni Roy of Mallaguri, P.S. Pradhan nagar, Dist- Darjeeling and arrange for its investigation.
