SPC would like to lodge a written complaint against the above noted accused person to the effect that today on 18.09.21 at 20:35 hrs myself along with force ASI Ratan Pradhan, CV/223 Swapan Chetri, CV-128 Ajay Kumar Sahani, CV-242 Rakesh Mauger, CV-646 Baban Chandra Das left from P.S for Special raid duty vide P.D.N. PS GDE NO 1131 Dated 18/9/21. During special duty I received an information that one person name Bambam Mahato alias Biswanath has stored large quantity of High Liquor in his house situated at Dagapur, Near Laha, Gobind Math, P.S Pradhan Nagar, Dist Darjeeling and selling the same from his house cum shop for illegal gain. Accordingly I share the information to you and as per your kind instruction I along with force rush to the spot and hold raid in the house of the above person. On searching his residence cum shop recovered above noted articles, and on demand he failed to produce any valid document in respect of the recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21:35 hrs to 21:55 hrs and after that I arrested him on 18:09:2021 at 22:05 hrs and brought to Pradhan Nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely **Bambam Mahato alias Biswanath (M-36) S/O Ram Nihora Mahato of Dagapur, near Savin Kingdom, P.S Pradhan Nagar, Dist-Darjeeling** and arrange for its investigation.
