Sir,

In producing herewith one accused person namely Taposhsarkar (24) S/o Lt Sahadeb Sarkar of Adarsha Pally, Ukilpara P.S- Raiganj, Dist. Uttar Dinajpur with seized articles viz;

- i. One plastic pouch contains 72 grams said to be Brown Sugar, Marked as exhibit- "A"
- ii. One plastic pouch contains 90 grams said to be Brown Sugar, Marked as exhibit- "B"
- iii. One Balckcolour plastic carry bag, marked as exhibit "C"
- iv. 05 grams of said to be Brown sugar extracted from the mother packet marked as "A: for examination and marked as exhibit "A-1"
- v. 05 grams of said to be Brown sugar extracted from the mother packet marked as "B" for examination and marked as exhibit "B-1"

I, S.I Dip. nkar Goswami of Pradhannagar Police Station, SPC do hereby lodged this complaint to the effect that on 19.09.2021 at 14.15 hrs received a secret source information that one person having possession of huge quantity brown sugar without valid documents and was selling to the drug addicted and other people at Mallaguri, Hill Curt Road, backside of Hunuman Mandir, under PS- Pradhannagar. Accordingly, the information was diarized vide Pradhannagar PS GDE No. 1182 Dtd. 19.09.2021 and also inform to you. As per your kind order myself along with force Const/1419 Ashis Roy, Const/1416 Dilip Kumar Barman along with SOG team SI Rash Bihari Saha, ASI Bir od Jha of Siliguri Police Commissionerate left for Mallaguri, Hill Curt Road, backside of Hunuman Mandir under PS- Pradhannagar by govt. vehicle WB-24 A 6765 and vide Pradhannagar PSM.C.C No- 2009/2021 Dt. 19.09.2021 to verify the veracity of information corresponding Pradhannagar PS GDE No. 1183 dtd. 19.09.2021.

At about 14.35hrs we arrived at Mallaguri, Hill Curt Road, PS- Pradhannagar and I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Sri Bishal Ray (20) S/O Sri Bablu Rai of Dagapur, near DPS, P.S. -Pradhannagar, Dist.- Darjeeling & (ii) Sri Chotu Paswan (28) S/O Lt Lipak Paswan of Collipara, Ward, No.1, P.S-Pradhannagar, Dist. Darjeeling and disclosed the matter regarding our information. I also requested them to accompany with us in the whole process during search and seizure if necessary, and subsequently being shown and identified by the source, we found that one person was standing and he supplying/selling something to some young boys. Seeing our team the young boys started to flee away from the spot. But we detained the above noted person along with above noted articles which was kept in his right hand. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he was carrying

"Brown Sugar" with him. Then I asked him whether he wanted to be search in presence of Executive Magistrate or any Gazette Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But he refused to search the police party. Accordingly, I informed the matter to Sri Subhashis Chaki, I/C Pradhannagar PS and requested him, to present at the spot for conducting search and seizure. At about 14.55hrs Sri Subhashis Chaki, I/C Pradhannagar PS arrived at the spot. Thereafter under the supervision of I/C Pradhannagar PS and in presence of independent witnesses I conducted search of the above apprehended person and recovered two pouches of said to be Brown sugar from the plastic carry bag in his right hand.


Then as per direction of Sri Subhashis Chaki, I/C Pradhannagar PS, I weighted the two plastic Pouches with weighing instrument being cried by us and found that total weight of recovered in two packets of said to be Brown sugar including Plastic Pouches having 162 grms (i.e 72 grms and 90 grms). Then I seized the said articles (i) One plastic pouch contains 72 grams said to be Brown Sugar, and Marked as exhibit-"A" (ii) 05 grams of said to be brown sugar extracted from the mother packet "A" for examination and market as exhibit A-1, (iii) One plastic pouch contains 90 grams said to be Brown Sugar, Marked as exhibit-"B", (iv) 05 grams of said to be brown sugar extracted from the mother packet "B" for examination and market as exhibit B-1 and (v) One Black colour plastic carry bag, marked as exhibit "C" under proper seizure list and labels under the supervision of I/C Pradhannagar PS SPC in presence of witnesses duly signed by them as well as the accused person. The whole process of seizure was made between 15.05hrs to 15.55 hrs. Then I arrested the above noted accused person after observing all formalities of arrest. The copy of seizure list and Memo of Arrest were supplied to above noted accused person as the accused person violated the terms and condition of N.D.P.S Act possessing Brown Sugar without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Taposh Sarkar (24) S/o Lt Sahadeb Sarkar of Adarsha Pally, Ukilpara, P.S- Raiganj, Dist. Uttar Dinajpur and arrange for its investigation.
