With due respect I, the undersigned hereby inform you that I am a resident of Milan More Near B.Ed College, P.S. Pradhan Nagar, Dist. Darjeeling hereby inform you that One Hema Oraon of Lower Fagu, Gorubathan, Dist. Kalimpong was working as a home made in my house since last one month. That on 15-09-2021 at about 1. To 1.30 P.M. I went to Ramkrishna Nursing Home, Siliguri to visit one of my relative at that time my daughter (aged about 2 yrs) was alone in my house at that time said Hema Oraon took from my house one 24 cerate gold beslet about 2 tola, one 24 cerate gold ring about ½ tola and cash Rs.17,000/(Rupees seventeen thousand) only when my daughter raised objection then said Hema brutally assaulted my daughter and my daughter sustained injury and she fled away. That I have made search everywhere as per my knowledge but could not found her as such I made this complaint on some delay. I think she left to her resident at Lower Fagu, Gorubathan, Dist. Kalimpong most probably.


