Complain for Dangerous Driving making personal serious injury.

Sir,

I Sri Jubaraj Karmakar S/O Sri Akhil karmakar of Hyderpara, Silliguri District Jalpaiguri, am writing to lodge a complaint before your department on an alleged traffic offence related to dangerous driving for your attention.

The incident happened on 14/09/2021 at about 5.30 pm in front of Hyderpara Club as one new purchased Motor Cycle being Engine No GE5FM2112822, Chassis Number ^{#MD637DE5142F12490*} on high speed hit my father - AKHIL KARMAKAR. AGED ABOUT 56 YEARS, who was going to our shop from our house. He was on his left side of the road when the said motor cycle being rash & negligent driving hit my father and knocked him down and he was senseless for some time.

The said motor cycle driver ran and fled away leaving the motor cycle laying on road when the passersby and some peoples are took my father Dr. Benu Gopal Das where he was treated initially, the ankle of the right leg fractures and the disc of the spinal cord is injured but the condition of my father going on detoriating had to admit before Neotia Getwel on 20/09/21 and admitted to CICU-10 on a serious having multiple fractures and injury in brain and other parts. By the said sudden act my father is in trauma and speechless.
