**Sub: Complaint against Sukumar Kundu, Sankar Kr. Kundu, Kalachand Kundu, Sapan Kundu, all are son of Sallelshwar Kundu, Saugata Kundu, Saikat Kundu and Saurab Kundu, all are son of late Sekhar Kundu, their men, agents and associates, resident of Bidhan Road, Siliguri.**

Respected Sir,

I, **Rupali Roy**, Daughter of Sri Nagendra Nath Roy, resident of Chhabavita, P.O. Fulbari Hat, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin-734015, do hereby lodge a complaint against Sukumar Kundu, Sankar Kr. Kundu, Kalachand Kundu, Sapan Kundu, all are son of Saileshwar Kundu, Saugata Kundu, Saikat Kundu and Saurab Kundu, all are son of late Sekhar Kundu, their men, agents and associates, to the effect as follows:-

- 1) That my father said Nagendra Nath Roy is the owner of all that piece or parcel of land measuring 2.02 Acres, recorded in R.S. Khatian No.347, comprised in R.S. Plot No.58, R.S. Sheet No.12, J.L. No.3, Pargana- Baikunthapur, Mouza- Binnaguri, P.S. Rajganj now New Jalpaiguri, Dist. Jalpaiguri, by virtue of a registered Deed of Gift being No.I-1505, dated-13-03-1961 executed by one Milchand Singh, i.e. my grandfather.
- 2) That thereafter, my father constructed tin shed residential structure in and over the southern part of the said land measuring 2.02 Acres and I along with my father have been enjoying and possessing the said land and residential premises.
- 3) That since few days, Sukumar Kundu, Sankar Kr. Kundu, Kalachand Kundu, Sapan Kundu, all are son of Saileshwar Kundu, Saugata Kundu, Saikat Kundu and Saurab Kundu, all are son of late Sekhar Kundu claiming to be the owner of the aforesaid land are trying to evict us forcefully and illegally but due to our resistance, they have not yet succeeded in their ill motive and wild mission but threatened and declared openly that they will come again and anyhow will dispossessed us from the said land and premises and there will be non to stop them and also uttered that the police authority works under their instructions and according to their whims and rhymes.
- 4) That on 20-09-2021 at about 11:00 PM, said Sukumar Kundu, Sankar Kr. Kundu, Kalachand Kundu, Sapan Kundu, Saugata Kundu, Saikat Kundu and Saurab Kundu, their men, agents and associates criminally trespassed into our aforesaid land measuring 2.02 Acres and residential premises, abused me and my father by
