Sir,

I, MISS. PRIYANKA BARUA, Daughter of Late. Pannalal Barua, residing at Church Road, Near Shani Maharaj Mandir, within ward No. 10 of Siliguri Municipal Corporation, Post Office & Police Station – Siliguri, District – Darjeeling in the state of West Bengal would like to inform you that on today i.e., on 23.09.2021 at about 4:00 PM when I was at home I suddenly heard some chaos in front of my house while looking into the matter I found that our former tenant (1) SRI SUNIL KUMAR SHAW (2) SRI VIJAY KUMAR SHAW both sons of Late Phool Chandra Shaw along-with their Mother i.e., wife of Late Phool Chandra Shaw along-with some anti social men and agents mostly non residents of Siliguri were into a scuffle with my uncle SRI TAPASH BARUA, son of Late Haripada Barua. When they noticed me they started shouting dirty and filthy words against me. In such a circumstance I along-with other members of my family came down to save my uncle who was all alone and was being brutally manhandled by said (1) SRI SUNIL KUMAR SHAW (2) SRI VIJAY KUMAR SHAW both sons of Late Phool Chandra Shaw along-with their Mother i.e., wife of Late Phool Chandra Shaw along-with some anti social men and agents. While doing the same they were uttering words that are defamatory and humiliating derogatory to human dignity in nature such as -

- (i) "Tumlog sala chota jaat ka hai yeh dukan kya pura ka pura building hi humlog kabja kar lega aur tumlog to jaungli admi hai jaake jungle me raho aadivasi kahi ka".
- (ii) "Bahot acha hua kam se kam 02 chota jaat mar k kam toh hua abhi Tapash v mar jaye to yeh pura building humlogo ka ho jayega aur baaki sab ko

humlog Jungle me bhej denge kyuki chota jaat ka tribal logo ka asli jagah Jungle hi hai".

(iii) "Tribal aur chota jaat ka jo log hota hai who log to nanga rehta hai tumlog kapra pehen k apne aap ko kya samajhta hai".

And while doing all such aforesaid illegal acts and activities (1) SRI SUNIL KUMAR SHAW (2) SRI VIJAY KUMAR SHAW both sons of Late Phool Chandra Shaw also intentionally tried to disrobe me by pulling my dress and hair causing breach of modesty in front of passerby and persons of my locality. They also abused and/or insulted me and my uncle and other family members including my deceased father and mother by calling us with our caste name as MAGH/TRIBAL.

Sir, due to aforesaid illegal acts and activities of (1) SRI SUNIL KUMAR SHAW (2) SRI VIJAY KUMAR SHAW both sons of Late Phool Chandra Shaw along-with their Mother i.e., wife of Late Phool Chandra Shaw along-with some anti social men and agents we are in tremendous mental shock and trauma.

Your good office is therefore requested to immediately start criminal proceedings against them under the Schedule Castes and The Scheduled Tribes (Prevention of Atrocities) Act and other relevant sections of Indian Penal Code and to put the wrong doers behind the bars.
