With due respect I Smt. Mary Sangtam Khati, W/o Sahadeo Khati, Of Matigara Road, Siliguri (S.M.CROP), Dist. Darjeeling- 734003, would like to draw your kind attention to the following effect that I am the registered Power of Attorney being No. 209/2017 dated- 18.04.2017 of 1. Smt. Durga Moktan, 2. Smt. Mona Lepcha, 3. Smt. Shila Pradhan, 4. Sri. Manish Yonzone and 5. Sri Dzogchen Moktan were the legal heirs of Chhena Dorjee Lama (Moktan) @ Cholem Dorjee Lama, now deceased, the aforesaid Chhena Dorjee Lama (Moktan) @ Cholem Dorjee Lama was the registered owner of land measuring about 2 acres or 0.7644 decimal recorded in Khatain No. 15 plot no-100, 111,114 & 129, Mouza Thiknikata, Pargana Phatarghata, JL NO- 74, P.S. Matigara, Dist-Darjeeling and said Chhena Dorjee Lama (Moktan) @ Cholem Dorjee Lama purchased the aforesaid land from one Patu Bhagat, vide DEED No- 1-776 dated-09.02.1968 and after the death of said Chhena Dorjee Lama (Moktan) @ Cholem Dorjee Lama the aforesaid legal heirs. That we are belongs to scheduled tribe however the aforesaid persons are trying to grab the aforesaid land for their illegal gain. The aforesaid persons except PRAMOTH SINGHA had occupied PWD land in-front of the aforesaid land being plot no-111 and also encroached some portion of plot no-111 they are trying to enter into the more aforesaid land and aforesaid PRAMOTH SINGHA already entered/grab some portion of aforesaid land of plot no- 111 and I several time went to the land and requested to them to vacate the same but they did not pay any heed, more so they are threatening me with dire consequences and also hurling dirty languages towards me, yesterday at about 4.30 pm I along with husband went to the aforesaid land and again requested them to vacated the encroached land but the hearing the same they became furious and tried to assault us by saying that we are belong to lower caste and have no manner and no power in a public place as a result I along with my husband sustained severe mental pain and suffering from depression. It is to be mentioned that for their encroachment by making several shops in-front of the aforesaid land some anti social persons are gathered there and they took wine/ganja etc and they are created obstruction for our ingress and egress.

Therefore you are requested to take proper step to recover the aforesaid from the clutch of those peoples and also punish them for hurling dirty languages in respect of caste in a public place as per-law.
