Sir,

In producing herewith one accused person namely Narayan Singha (52) S/O Lt. Nal Singha of Motajote, P.O + P.S- Matigara, Dist.- Darjeeling along with seized articles viz., 1) 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.2 liters, value Rs.1200/-), and marked as 'exhibit -A' and 2) one bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1" I,PSI Newton Biswas presently posted at Matigara Police Station,Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (24.09.2021) at 18.10hrs acting on source information, myself along with ASI Nitai Mandal, C/1035 Santosh Rabidas and CV-155 Sukumar Das had been to Motajote area and found that the aforesaid person had been selling illegal liquor to the common customers in his shop at Motajote under Matigara PS. Then I cordoned the shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain. On being search of him in presence of available witnesses the above noted seized articles are found inside a bag found from his conscious possession. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place, the persons who were having liquor at that shop manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 19.05 hrs. to 19.25 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused persons namely Narayan Singha (52) S/O Lt. Nal Singha of Motajote, P.O + P.S- Matigara, Dist.- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
