In producing herewith the five arrested accused persons namely (i) Krishna Sahani (19), S/O Janak Sahani of Durgaguri, PS - PDN, Dist - DJG, (ii) Jadb Barman (26), S/O Sailesh Barman of Balason Colony, PS - MTG, Dist - DJG, (iii) Ajay Kr. Sahani (22), S/O Bijay Sahani of BRI Colony, PS - PDN, Dist - DJG, (iv) Harasundar Singha (18), S/O Sambhunath Singha of Ramkrishna Jote, PS - MTG, Dist - DJG, (v) Md. Israil (22), S/O Md. Ismail of Debidanga, PS - PDN, Dist - DJG arrested u/s 41 Cr.P.C.

I, PSI. Shekhar Adhikary of Matigara PS SPC lodged this written complaint to the effect that on 25.09.2021 while performing SPL Mobile duty under Matigara PS area found five persons namely (i) Krishna Sahani (19), S/O Janak Sahani of Durgaguri, PS - PDN, Dist - DJG, (ii) Jadb Barman (26), S/O Sailesh Barman of Balason Colony, PS - MTG, Dist - DJG, (iii) Ajay Kr. Sahani (22), S/O Bijay Sahani of BRI Colony, PS - PDN, Dist - DJG, (iv) Harasundar Singha (18), S/O Sambhunath Singha of Ramkrishna Jote, PS - MTG, Dist - DJG, (v) Md. Israil (22), S/O Md. Ismail of Debidanga, PS - PDN, Dist - DJG were loitering near Barsana Hotel, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.


