In producing herewith four(04) arrested accused persons namely (i) Md. Manglu(19) S/O Faumuddin of Biswas colony, P.O+ P.S- Matigara, Dist- Darjeeling, (ii) Pappu Roy (29) S/O Gobind Roy of Rajendra Nagar, Coolie Para, P.O + P.S- Pradhannagar, Dist- Darjeeling, (iii) Abhishek Rawat (20) S/O Suresh Rawat of Geng Tea State Garwgawa, P.O- Lebong, P.S- Sadar, Dist- Darjeeling A/P Jhankar more, P.S- Siliguri, Dist- Darjeeling, (iv) Md. Kalu Sk. (36) S/O Md. Alfat Sk. Of Paribahan Nagar, P.O+P.S- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made Crowbar measuring 26 inch (approx) in length from the possession of Md. Manglu which was kept on his right hand,
- (2) One iron made sword measuring 30 inch (approx) including wooden handle from the possession of Pappu Roy which was kept concealed on his back side
- (3) One iron made 'Katari' measuring 26 inch (approx) including wooden butt from the possession of Abhishek Rawat which was kept concealed on his back side,
- (4) One Iron rod measuring 40 inch (approx) in length from the possession of Md. Kalu Sk. which was kept on his right hand,

I, PSI- Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md. Manglu, (ii) Pappu Roy, (iii) Abhishek Rawat, (iv) Md. Kalu Sk. and (v) Md. Sagar, (vi) Rana Thakur, and others to the effect that today on 24.09.2021 at 22.15 hrs received a sources information that 10/12 youths have assembled at Phansidewa More, near Jishu Asram under Matigara PS with a view to commit dacoity in a Night Super Bus. The fact was diarized in GDE vide Matigara PS GDE No- 1351 dated 14.09.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, ASI Nitai Ch. Mandal, C/986 Rajib Sarkar, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information.

At about 22.55 hrs after reaching at Phansidewa More, near Jishu Asram PS- Matigara I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above noted four (04) accused persons namely Md. Manglu, Pappu Roy, Abhishek Rawat, and Md. Kalu Sk along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a Night Super Bus. It is also revealed from them that Md. Sagar, Rana Thakur and some others have assembled there with them and planned for committing the dacoity.
