Sir,

In producing herewith one (01) accused namely Ghrito Barman (58), S/O Lt. Khagendarnath Barman of Dhukuria, Patharghata, PO New Chumta, PS Matigara, Dist- Darjeeling, under arrest along with following articles under proper seizure;

1. 12 (Twelve) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. (total 600ml X 12=7.2Ltrs.) and marked as Exhibit - A.
2. 01 (One) bottle of Himalayan Gold Spirit containing 600 ml, taken out randomly from Exhibit A for examination and marked as Exhibit A-1.

I, S.I. Abhishek Theengh of Matigara P.S, SPC do hereby lodge this Suomoto complaint against the above noted accused person and the above seized article to the effect that on 25.09.2021 at around 20:05 hrs received a source information that one person namely Ghrito Barman had been processing liquor and spirit illicitly and has been selling at Patharghata, at his house under Matigara P.S, Dist- Darjeeling. There had been a further complaint that due to sale of illicit liquor the peaceful environment of the locality has been deteriorated and has been very difficult for local people to live due to antisocial activities of the dunkers, who drinks in the house of Ghrito Barman. Noted the same vide MTG P.S GDE No 1386/2021 Dated: 25.09.21 after sharing the information with my officer in-charge and as per his direction and subsequently, I along with ASI Nitai Mandal, C/1035 Santosh Robidas and had been to Dhukuria, Patharghata, PO New Chumta, PS Matigara to verify the veracity of the information at and as shown by the source, I, then conducted raid, searched in the house of the above noted accused person and from his possessing found the above noted articles which were selling in his house. He disclosed his name as mentioned above. Then I seized the above noted illicit liquor and spirit under proper seizure list in presence witnesses and also labelled the same. The whole process of seizure and labelling was made in between 20:55 hrs to 21:15 hrs. On interrogation, He admitted that he procured the liquor, spirit illegally and had been selling them illegally to the people. Thereafter, I arrested him u/s 41 Cr.P.C. by preparing a proper memo of arrest in presence of witnesses.

I, therefore pray before your honour to take legal action as per law against the accused person namely Ghrito Barman (58), S/O Lt. Khagendarnath Barman of Dhukuria, Patharghata, PO New Chumta, PS Matigara, Dist- Darjeeling under proper section of law.
